



March Career Pre-View Events 2011

BEP along with partners; Yakima Valley Community College & Centers for Excellence, Yakima Valley Tech Prep; Yakima Valley Skills Center, Allied Health; held a three day Career Pre-View Event; March 23rd, 24th and 25th.

Close to a thousand students, presenters and volunteers participated during this three day event. Nearly 50 hands-on workshops were made available to valley students; giving the students up close and personal experiences in career fields of interest. The students' experiences were much richer and more informative than a typical career pre-view placement within these fields could be.

In a controlled environment and absent of privacy issues, our students were able to operate a back-hoe, race robots, partake in an emergency rescue, learn to suture, design a child's book; to name only a few of the opportunities available.

On March 23rd the YV-Tech Skills Center hosted Construction Day. Students from around the valley participated in handson workshops, including but not limited to; cabinetry, masonry, plumbing, operating a back-hoe and crane.

On March 24th the Yakima Valley Community College hosted Engineering, Education, Information Technology, and Health Occupations Day. Some handson workshops included; building a robot, designing a webpage, creating a child's reading book, canine CPR, and suturing pigs' feet.

On March 25th the YV-Tech Skill Center hosted Public Safety Day. A few of the hands-on workshops students experienced included; drug and arson dogs, swat/bomb, Fire Marshal, Fish & Game, forensics and ICE.

On all three days lunch was served to all participants; students, supervisors, volunteers and presenters. 


