leaders the necessary skills to be able to serve our diverse community, and provides them with an opportunity to discover many different organizations and agencies that need volunteers and board members.

Leadership Yakima was established in 1986 by the late-Gary Webster, Mel Wagner, Bob Hall, and Ron King. The first class had 29 members, and 730 participants have graduated from the program in its 30-year history.

I first heard about LY in 2000. I read an article about graduation and

started to look into receiving glowing reports from several friends and colleagues, I applied and was accepted into the Leadership Yakima Class of 2001.

Each class member is required to attend a two-day retreat in 📡 September. At first I wasn't very excited about the prospect of "camping out" with a group of strangers. But after that weekend at Camp Dudley (the current home of the retreat is Lost Creek Village), my mind was changed We had great speak-

ers and learned so much about the Valley, and I had the chance to make new friends. The retreat ended up being one of the best parts of LY, a sentiment that is often voiced by new graduates.

The retreat is followed by nine monthly sessions. Each session has a leader and a theme, such as Education, Health Care and Business Climate. Participants will hear from a variety of speakers and take tours of businesses and organizations associated with that month's theme. After a final session in June, the class is celebrated at a graduation ceremony.

In addition, each class member is placed into one of four groups for their community action project. Each group has to come up with a project idea, complete with budget and outline, that will benefit the community. The project is to be completed by the end of the class, and is highlighted at

Over the years, countless Leadership Yakima graduates have taken board positions and become community leaders. One LY graduate is a Yakima County Commissioner, two graduates currently sit on the Yakima City Council, and some have been honored with the prestigious Ted Robertson Community Service Award. But just as important, all of the graduates have become more connected to their community.

> The best recommendation you can get about the value of Leadership Yakima is to ask any-

one that has been in the program. Usually you'll get memories of their classmates, the friends they made, recollections of tiring, yet educational session days, what their project did for the community, and about the knowledge they gained from all the session leaders and presenters.

Joining Leadership Yakima is one of the best professional decisions I have ever made. I am from the Yakima Valley, and thought I was aware of what our community had to offer. But the year I spent in LY really opened my

eyes to the many wonderful organizations, businesses and people that make up our Valley. I was the Class Representative, and liked the experience so much I asked to be on the Executive Committee. I have served on the committee many times since then (off and on) and have been the chair and co-chair.

Currently Kristi Foster is the Director of Leadership Yakima, and has worked very hard to evolve the curriculum, making changes and updates as needed. She and her committee spend countless hours working on the program. Every committee member is a graduate and has a love of Leadership Yakima.

The LY Class of 2017 has 27 members, the largest group since 2008, and just started in September. All of the classes are special, but there is something about this group. I can't wait to see them at the end of year.

Surgical Robots Invade Pacific Northwest University Campus



Washington ESGR Breakfast with the Boss Honors Supportive Employers

YAKIMA, Wash. - YAKIMA, Wash. - The Greater Yakima Valley Chamber of Commerce and volunteers from the Washington Employer Support of the Guard and Reserve (ESGR) volunteers gathered in Yakima at an ESGR sponsored Breakfast with the Boss event. ESGR's Breakfast with the Boss brings together employers, unit commanders, ESGR volunteers and community leaders to discuss issues related to service in the Guard and Reserve.

The ESGR volunteers presented a briefing on the Uniformed Services Employment and Reemployment Rights Act (USERRA), which is the federal law that prohibits discriminatory, punitive or unlawful action against any member of the Guard or Reserve because of their performance of uniformed military service.

The event also recognized local employers who have gone above and beyond to support those who serve in the Guard and Reserve. The Greater Yakima Chamber of Commerce was presented with the Seven Seals award.

The Seven Seals Award is presented in recognition of significant individual or organizational achievement, initiative, or support that promotes and supports the ESGR mission, to include the efforts of the more than 4,500 volunteers who carry out ES-GR's mission across the Nation on a daily basis. "The Greater Yakima Chamber of Commerce has gone above and beyond to support the military efforts in the Yakima Valley, whether it's Active Duty, Veterans, or Guard and Reserve," said Mary Miller, the Area Chair for the West Central Committee for the Washington ESGR. "They have shared their time and space to accommodate events and announcements. The Greater Yakima Chamber of Commerce has partnered with the community in sponsoring the Job Fair and Veteran's Stand Down which serves a large military community."

Also recognized for their support of those who serve in the reserve components was the Yakima Police Department, Brumback Law Group, and Baxter Construction who were

nominated for a Freedom Award. The Freedom Award is the highest recognition given by the U.S. Government to employers for their outstanding support of employees serving in the Guard and Reserve. Each year, Guard and Reserve employees, or a family member acting on their behalf, have the opportunity to nominate their employer for the Employer Support Freedom Award. "It is the existence of civilian employment such as those recognized today that enables many to remain an active and integral part of the critical strategic role played by today's Guard and Reserve," Miller stated.

ESGR, a Department of Defense program, seeks to foster a culture in which all employers support and value the employment and military service of members of the National Guard and Reserve in the United States. Dozens of PNWU medical students were captivated during a presentation by Yakima physician Jason Cundiff, MD, as he talked about his experience with the da Vinci surgical robotics system.

Dr. Cundiff played a major role in bringing the robotics system to the campus of Pacific Northwest University. He is one of the top users of the robotics system in the west and told students he has completed nearly 1,300 procedures with the equipment over the last $4\frac{1}{2}$ years.

Dr. Cundiff worked with PNWU student Seth J. Minton, OMS II, to help make arrangements for the demonstrations in front of his fellow students possible. More than 50 medical students enjoyed watching and experimenting with the highly technical equipment, along with local physicians and others in the community who stopped into the University Conference Center to see the equipment owned by the company Intuitive. In fact, students had a chance to compete for prizes for the best performance of simple tasks such as suturing a wound on a synthetic demonstradid the same.

Dr. Cundiff wanted to share part of what the future holds for those currently attending medi-

cal school. "I got trained on this equipment within the first couple of months of its arrival in Yakima and I love it."

As Dr. Cundiff showed the students slides and videos from several of his operations with Da Vinci equipment he said, "It has well-demonstrated benefits. I am a strong believer that it does make a good surgeon better when he is committed to it."

When asked how a surgeon in a relatively small town in central Washington has become one of the busiest robotics surgeon in the entire western part of the country Dr. Cundiff said, "It (Yakima) has just the right amount of trauma here that allows me the volume of surgery to stay proficient without overwhelming my practice. It is just the right mix of opportunity for me."

Dr. Cundiff was excited to be on campus and show off the equipment. He uses it often and also loves to teach students on a regular basis as a preceptor for PNWU's College of Osteopathic medicine students.
