Make an impact

By contributing to local Children's Miracle Network Hospitals campaigns, we are ensuring a healthier future for our community. Since 1993, Virginia Mason Memorial has been an active member of CMN Hospitals, a nationwide grassroots effort to raise awareness for children treated by their local CMN hospital. Virginia Mason Memorial is one of only three CMN Hospitals in the state, the other two being Seattle Children's and Sacred Heart Children's Hospital in Spokane.

In partnership with Virginia Mason Memorial, The Memorial Foundation exists to empower community members in stewarding the development and sustainment of health care options in Yakima. By assessing our community's needs, The Memorial Foundation focuses on encouraging donor support toward four areas to improve the overall health of our community: Cancer Care, Children's Health, Compass Care, and Healthy Yakima.

As the largest nonprofit community hospital in our region, Virginia Mason Memorial is the only comprehensive service provider for children in Central Washington and has long served the needs of our smallest of patients. The hospital's doors opened on June 20, 1950. The first baby was born there the next day. Memorial's pediatric services include a regional-serving Level-III Neonatal Intensive Care Unit, Central Washington's only pediatrics unit, and Children's Village.

No doubt you've seen the paper balloons covering the walls of businesses around town. The Memorial Foundation has coordinated the efforts of many local businesses that step up each year to raise money for children here in Central Washington. Fundraising efforts continue throughout the year—each one impacting local kids like Francisco.

This year, we are committed to raise \$780,000 to fund specialized medical care and therapy services at Children's Village for children with physical, developmental, or behavioral delays and impairments. We will also raise more than \$270,000 to fund other children's initiatives in Memorial's pediatric, maternal health services, and neonatal intensive care units.

Children and their families across Central Washington are in need. As you read this, a child is being born who needs services now or might need them in the future. With the support of our community and the local and national partners that raise funds and awareness through CMN Hospitals, you have the opportunity to make a direct impact on more than 13,000 children here in the Yakima Valley.

Meet Francisco Carriedo, an 11-yearold from Cowiche, the 2019 Children's Miracle Network Hospitals Champion representing Virginia Mason Memorial on a national scale. As our miracle child, Francisco will be featured during campaigns, events and programs.

Francisco was born with VACTERL syndrome and has depended on vital therapy services at Children's Village since he was a year old. In his short life, he has had 15 surgeries, including the amputation of his leg, new knees, and plate installations in each hip. Francisco relies on Children's Village for follow-up therapy after surgeries (the therapy pool helped him relearn to walk after his leg was removed).










Rod's House is excited to share the tremendous positive impact the community is making on our community's young people. In 2018, 380 unique young people visited Rod's House. While that sometimes feels like an overwhelming number of young people in need, we are glad to be a resource. incredible young people are surviving; they are attending and graduating from high school or earning their GED; they are accessing individualized support to develop plans to reach their goals; they're enrolling in Yakima Valley College, Perry Technical Institute, and other post-secondary schools to earn certificates and degrees; they're joining the workforce, finding secure housing, and reaching their full potential in our Valley. We are seeing young people giving back of their time more than ever, volunteering at the House and other organizations in the community.
