



Committed to caring for the Yakima Valley

We have always worked to provide greater access to care for patients in the Yakima Valley. Access to care is Virginia Mason Memorial's (VMM) top priority in our current Community Health Needs Assessment. It is the framework that guides our efforts to improve health care in Central Washington.

Our work to increase access goes hand in hand with the vast changes we have seen over the past few years in the health-care landscape of our country. Both issues were, in fact, important factors in our decision to seek out a quality health care partner, which we found in the Virginia Mason Health System.

In May 2019, the wisdom of our decision became startlingly clear when Astria Health filed for bankruptcy, putting the future of Yakima's only other hospital, Astria Regional, in jeopardy. It was then that we doubled our efforts to open avenues to care across our entire spectrum of services. Should Astria Regional close its doors, we needed to assure our community that we were prepared to serve every patient who came through ours.

Throughout 2019, VMM leaders gathered daily and weekly for status and planning updates. Access to care was always top of mind, whether that care was provided in our Emergency Department, our primary care offices or at our specialty centers.

Early in 2020, that work paid off. On January 8, Astria announced it was closing the hospital. Leaders from Virginia Mason Memorial and Virginia Mason put plans into action. Immediately we reached out to our community

partners to assure that essential services would continue and that we're doing what's best for our community.

Within two weeks VMM opened a third HealthyNow convenient-care clinic: this one on the Memorial hospital campus. The new clinic is open evenings until 10 p.m. three days each week (to start) to offer patients coming to our Emergency Department a faster, less-expensive option. We have also created 60 to 90 openings per day at our primary care offices.

Meanwhile, teams from our Human Resources department worked diligently to add staff, many from the newly closed hospital. To do so, we streamlined our hiring process and increased access to onboarding for our new team members.

The Virginia Mason Memorial team is committed to caring for the Yakima Valley and has stepped up to the challenges faced in early January. Work continues on many fronts. But one thing remains unchanged—our commitment to our Mission, Vision and Values:

- To create healthy communities one person at a time.
- To achieve health with you in new ways.
- With respect, accountability, teamwork, stewardship and innovation.

Passenger Rail Summit to Discuss Prospects for Central Washington Service

Yakima, WA — Central Washington needs better transportation options, according to All Aboard Washington (AAWA), a non-profit organization that supports better passenger rail service in the Pacific Northwest.


Passenger rail service would give Central Washington residents improved access to Seattle, the Tri-Cities, Spokane, and points beyond. Passenger rail service benefits the elderly, disabled, students, those with limited income, and those who simply prefer not to fly or drive. According to the Washington State Ultra-High-Speed Ground Transportation Business Case study, passenger rail is seven times less carbon intensive than single-occupant driving and twenty times less than flying on a passenger-mile basis.

A Washington State-funded feasibility study to evaluate restoration of passenger rail service through Central Washington is currently being conducted. To increase awareness, All Aboard Washington and the Greater Yakima Chamber of Commerce are co-sponsoring a Passenger Rail Summit Saturday, March 14, 2020, from 11:00am – 2:00pm at the Yakima Convention Center. The general public, business owners, and state/local government officials are invited to attend.
