CHAMBER HISTORY

Honoring our Past Presidents

The 1937 President of the Chamber Board was **Mr. C. W. Halverson**, who moved to Yakima in 1927 after graduating from Stanford Law School. The year he served as Chamber President he was 33 years old. In 1967 the President of the Chamber Board was **Mr. Fredrick. N. Halverson**, age 34. Father and son, both attorneys, loved to golf, hunt ,and fish together. Fred said, "Dad never openly encouraged me to become a lawyer. He was more concerned that I do something I would be happy doing." Fred once told a reporter that his real decision to become a lawyer was "right after I passed the bar exam."

In the 1930's, Mr. C. W. Halverson served alongside Mr. Ted Robertson, for whom our valley's coveted annual Chamber award for philanthropy is named. A major project then was the Roza Canal. "Since this was during the Depression, it was hard to convince legislators in D.C. that they should be spending money on irrigation projects." But after great effort, in 1935, five million dollars was appropriated to begin the project. "This irrigation gave the Yakima Valley a tremendous boost."

At that time the Chamber's office was located on the second floor of the Chinook Tower on East Yakima Avenue. A general manager, bookkeeper, and stenographer made up the staff. In reminiscences of his Chamber tenure, Mr. Halverson recalled, "We were always trying to find new members. Our goal was to promote the betterment of the Yakima community and secure more businesses in Yakima."

He once told a reporter at the Republic the story of the shortest and best treasurer's report, "All the bills are paid and we have \$12 in the bank." He found out five days later when the staff bookkeeper quit that \$5,000 in unpaid bills

were in his desk. "I had my work cut out for me when we found those bills. We called in our good supporters such as Cascade Lumber and Yakima Hardware, attempted to collect as many unpaid bills as possible, and held fund-raisers to help reduce our debt. This was no easy task."

In 1967 the Chamber's \$65,000 project "Forward Yakima" was underway when Fred took office. The project had been launched the year before by John R. (Jack) Kelly of Pacific Power and Light, marketing Yakima as an agricultural, industrial and recreational center, including the production of a color movie of Yakima. Fred was a graduate of Gonzaga University law school and worked for the county prosecutor's office for two years, and then Fred joined his father's firm, Halverson, Applegate, McDonald and Weeks.

During this time Yakima Meadows horse racing brought 1.5 million dollars of "outside money" to our Valley. Fred was quoted in a newspaper article, titled "Forward Yakima, Yakima Meadows now in the black", saying, "Someone once called horse racing 'The Sport of Kings" only for the royal touch. Well, we have the royal touch here in the Yakima Valley available for all citizens. See you at Yakima Meadows."

Fred served the board along with Ralph (Sarg) Hubbard of Sarg Hubbard's Store, Euclid Gamache of Country Shopping Center, Don Corcoran of Central Pre-Mix Concrete, and Charles M. Holtzinger of Holtzinger Fruit Company, Robert P. Lewis of Cook-Lewis Company, and John M. Larson, Mayor, City of Yakima. Other tasks set for 1967 were the completion of I-82 between Ellensburg and Yakima, expanding our higher education facilities, and to "Exploit our enviable climate, location and reputation as a "Host City". C.W. once said he came to Yakima "because I wanted a place I could go and make \$125 a month. After living here many years he said, "It's the best place in the world to live." *Complied by; E. JOHNATHON'S HELICOPTER



A few weeks ago, a mother of a critically ill young man called the Children's Wishes and

Dreams office in Yakima asking to fulfill a wish for her son, Johnathon. He wanted a remote controlled, gas-powered helicopter he could fly outside. Heidi Anderson, executive director of Children's Wishes and Dreams, began her research. She contacted hobby stores and a gentleman who could spend some time with Johnathon to teach him to operate the helicopter beginning with a battery powered unit to practice indoors.

Monday, February 13th, Heidi received a call from Johnathon's mother informing her that Jonathon was in the hospice unit at Memorial Hospital. Johnathon asked if he could see a real helicopter land and then lift off again. Heidi realized the urgency of the mother's request and immediately called the Yakima Firing Center. She was referred to Fort Lewis, then referred to other military and hospital contacts. After many calls and referrals by Heidi and her assistant, she was notified that the Army had a helicopter in the air and could be at the hospital in twenty minutes. She was able to talk to the flight commander and told him of the specific circumstances with Johnathon's situation.

Fortunately, Johnathon's room in the hospital provided a view of the helicopter landing pad on the roof of the hospital. The Army helicopter landed on the hospital roof and the flight commander and crew went into the hospital and into Johnathon's room to say hello and present Johnathon with his very own flight wings. The flight crew then left and lifted off from the landing pad only to then inform the mother that Johnathon should continue watching out the window as they honored him with a "fly by" to complete his wish.

All of these actions to fulfill Johnathon's wish came to be in a very short period of time, less than an hour. Nobody knew just how timely and special this event would be to everyone involved, especially Johnathon.

He passed away shortly after the helicopter flew by his window. They had given him his wings so he could fly. *The story continues*.....

Children's Wishes & Dreams had their Annual Dinner Auction on the following Saturday. Johnathon's mother said she wanted to donate back to us the helicopter that was purchased for Johnathon. We decided that we would auction this off in memory of him. In appreciation and recognition for the tremendous efforts put forth by the U.S. Army Air Ambulance Detachment, we invite those who were involved in this special wish to be our guests at the dinner. We reserved a special table for them at the front of the room and they were all there in dress uniforms giving a true felling of respect and appreciation.



Before the auction the Sevigny Sisters, our evening's entertainment, ended the program by singing a tribute to all branches of the military. It was especially moving when our special guests stood to their song. Following this the auction began with Johnathon's helicopter being the first item. Heidi told Johnathon's story and the standing ovation for these officers was an awe-inspiring moment. It was enhanced even further as the auction began with one of the officers bidding on the helicopter, as well as someone else in the crowd. As the bid got beyond the officers limits, a local business owner, Brent Hodson, stepped forward to continue the bidding to ensure the helicopter would go home with the officers. Another applause broke out as this transpired and they received the helicopter.

This was truly the most touching and moving event we ever had!

New Vision, Yakima Valley Human Resource Association Partner to Assess the Region's Talent Attraction Issues They Invite You to Participate in a Short Survey



One of the biggest business retention issues facing our Valley surrounds talent attraction. Local employers express consistently that they have difficulty filling technical and professional positions with their companies. Businesses often have to put lots of energy towards recruiting skilled employees from outside the community and work diligently on retaining them.
